The *Republic of Turkey* through its Ministry of Agriculture and Forestry (“MoAF”), *has received* financing in the amount of US\$ 341,27 equivalent from the World Bank toward the cost of the *Turkey Climate Smart And Competitive Agricultural Growth Project (TUCSAP)* and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project.

The project will include the following components;

Component 1: Institutional Capacity Strengthening for Climate-Smart Agriculture Policy, Planning, and Investments (US\$151.5 million IBRD). Activities under this component will support the strengthening of broad sectoral capacity, with a particular focus on narrowing information gaps in relation to Turkey’s soil and land natural capital, to enhance its sustainable planning and management. Component activities will also enhance MoAF’s digital blueprint for data collection and information management to contribute to effective policy monitoring and programming and support improved decision- making across the agricultural sector.

Under Component 1, the following activities will be contracted via International Open Market Approach:

1. Group I - Preparing Plans/Notes and Land Classification (Kirkclareli, Edirne, Canakkale, Tekirdag, Balikesir, Bursa Aydin, İzmir, Manisa & Yalova)
2. Group II - Preparing Plans/Notes and Land Classification (Afyonkarahisar, Antalya, Bilecik, Burdur, Denizli, Eskisehir, Isparta, Kocaeli, Kutahya, Mugla, Sakarya & Usak)
3. Group III - Preparing Plans/Notes and Land Classification (Ankara, Bartin, Bolu, Duzce, Istanbul, Karabuk, Karaman, Konya, Mersin & Zonguldak)
4. Group IV - Preparing Plans/Notes and Land Classification (Aksaray, Cankiri, Corum, Kastamonu, Kirikkale Kirsehir, Nevsehir, Nigde, Sinop & Yozgat)
5. Group V - Preparing Plans/Notes and Land Classification (Adana, Adiyaman, Gaziantep, Hatay, Kahramanmaras, Kayseri, Malatya, Kilis, Osmaniye & Sivas)
6. Group VI - Preparing Plans/Notes and Land Classification (Amasya, Artvin, Bayburt, Giresun, Gumushane, Ordu, Rize, Samsun, Tokat & Trabzon)

7. Group VII - Preparing Plans/Notes and Land Classification (Batman, Bingol, Diyarbakir, Elazig, Erzincan, Erzurum, Mardin, Mus, Sanliurfa & Tunceli)
8. Group VIII - Preparing Plans/Notes and Land Classification (Agri, Ardahan, Bitlis, Hakkari, Igridir, Kars, Siirt, Sirnak & Van)

Some of the other activities envisaged under Component 1 are: (i) Group I -VIII Soil Surveys and Classification; Laboratory Analysis; Production of digital detailed soil maps (1:5000); (ii) Recruitment of a Consulting Firm for conducting survey/s, feasibility studies; Preparation of detailed designs and Bidding Documents including technical specifications/BoQs for the National Soil Archive Facility; (iii) Construction Works for the National Soil Archive Facility; and (iv) Procurement of Information Systems for Establishment of National Soil Monitoring Sub-system for selected indicators, National Soil Profile Database, Dynamic Modelling/Mapping System; Soil-land soil degradation index (SDI) and National Soil Land Information System and Decision Support System (DSS) and Production of soil property and thematic maps and etc.

Component 2: Enhancing animal health capacity for effective disease surveillance, diagnostics and control (US\$81.2 million IBRD). Climate change increases livestock susceptibility to diseases and influences the emergence and proliferation of disease hosts and vectors. Effective animal disease surveillance and diagnostic capabilities along with veterinary medicines and vaccines are needed to prevent or control emerging and re-emerging animal diseases and zoonoses. This component will support MoAF's General Directorate of Food and Control (GKGM) on strengthening these important public functions. The component will support strengthening the capacity of Veterinary Control Institutes (VCIs) and the establishment of the National Veterinary Medicinal Control Center.

Under Component 2, the following activities will be contracted via International Open Market Approach:

1. Recruitment of a Consultancy Firm for conducting the Preparatory Studies, Design Review & Supervision of the Design Supply & Installation Contract of Control Center for Veterinary Medicinal Products (VETKOM)
2. Design, Supply & Installation Contract for VETKOM

Some of the other activities envisaged under Component 2 are: (i) Design, Supply and Installation Contracts of BSL 2 and BSL 3 Labs in Adana, Konya, Elazig, Erzurum, Samsun, Istanbul Pendik and Izmir Bornova Veterinary Control Institutes (VCIs) in 3 separate tenders (6 lots); (ii) Consultancy Services for conducting the Preparatory Studies, Design Review & Supervision of Design, Supply & Installation (DSI) Contracts of Adana, Konya, Elazig, Erzurum, Samsun, Istanbul Pendik and Izmir Bornova VCIs in 3 separate contracts; (iii) Procurement of Necropsy sampling and preparation equipment, necropsy clothing and material storage bags and etc.

Component 3: Investments for Enhanced Productivity, Resource- Efficiency, and Climate Resilience (US\$99.75 million IBRD, US\$33 million Beneficiaries). This component will support the dissemination, validation and adoption of Climate- Smart Agriculture (CSA) technologies and practices, as well as RD&I efforts. The component will encourage the uptake and effective use of innovative/disruptive CSA technologies/practices by closing knowledge and skill gaps and by providing financial support and technical assistance to producers and enterprises.

Some of the activities envisaged under Component 3 are: (i) Recruitment of Consulting Firm for Design / Design Review, Preparation of Bidding Documents, Provision of Technical Assistance in Bid Evaluation/s & Supervision Services; (ii) Construction Works for Geothermal Heating System Geothermal drillings, Installation and Commissioning of the Well Equipment, Geothermal pipelines and the Heating Plant) for Pilot Project in Specialized Greenhouse Industrial Zones Based on Agriculture (Geothermal Sourced); (iii) Infrastructure Works (Irrigation, Sewerage and Rainwater Networks, Road Construction, Electricity, Telecommunication and Natural Gas Networks and etc.) for Pilot Project in Specialized Greenhouse Industrial Zones Based on Agriculture (Geothermal Sourced); Recruitment of a Consulting Firm for Quick Assessment of the Smart Technology Landscape and Identification of Pilot; (iv) Procurement of Goods for Capacity Enhancement of Smart Technology Hub under the Test Center (Multiple Contracts); (v) Procurement of vehicles for manure collection/transportation; and (vi) Design, Supply & Installation of Biogas Unit, Energy Production Unit and Fertilizer Production Plant and (vii) various Lab & Research equipment and materials for Research Institutes and other goods procurements for Enhancing the R&D Innovation Capacity (viii) Construction & Renovation of the Agricultural Mechanization R&D and Innovation Center (incl. Laboratory Equipment; Research Equipment; IT Equipment).

Component 4: Project Management, Monitoring, and Evaluation (US\$8.65 million IBRD). Activities under this component will support all project management functions. It will include support for: (i) strengthening capacity for day- to- day project management of technical, fiduciary, Monitoring and Evaluation (M&E), Environmental and Social (E&S) issues; (ii) grievance redress, citizen engagement, and implementation of the communications; and (iii) M&E of project activities, including impact assessments, beneficiary satisfaction surveys, and development of an integrated system for project management and monitoring of project outputs and outcomes.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's *Procurement Regulations for IPF Borrowers (November 2020) (Procurement Regulations)*, and is open to all eligible firms and individuals as defined in the *Procurement Regulations*. The World Bank shall arrange the publication on its external website of the agreed initial procurement plan and all subsequent updates once it has provided a no objection.

Specific procurement notices for contracts subject to open international competitive procurement will be announced, as they become available, in [UN Development Business](#) online, on the World Bank's external website and Project's and the Ministry's official web sites and a newspaper of national circulation in the Borrower's or in the official gazette.
